MINUTES OF REGULAR MEETING, NOVEMBER 7, 2022

1. CALL TO ORDER: The meeting was called to order at 7:00 PM by Chairperson Angell. Present were Committee members Cardwell, Currington, Melero and Wais.
2. AGENDA ORDER: No requests for items out of order.
3. PUBLIC COMMENTS ON NON-AGENDA ITEMS: Dan Robertson said the November issue of the Crockett Signal is out, including the Sheriff's activity log.
- 4.a. REPORT FROM DEPUTY: Deputy Sheppard reported that in October there were 336 calls for service, 21 reports taken and 5 select crimes, mostly property crimes. There was an armed robbery at the gas station after 8:00 pm. A lengthy discussion took place regarding truck repair at the plaza, including leaking oil. Deputy Sheppard reported he usually gives the resident citizens time to resolve the issue, but he will tighten up his leniency.
- 4.b. REPORT FROM CHP ON TRAFFIC ISSUES: Not in attendance. Mr. Angell reported that Officer Leviste has been transferred to another position.
- 5.a. AUTOMATED LICENSE PLATE READER (ALPR) CAMERAS: Mr. Angell reported there was additional grant monies available through the Sheriff's office. Discussion was held on writing the grant and finding what monies are available through our payments for the Resident Deputy that was never utilized. Ron Wilson explained that grants need to be submitted on March 31 and September 30 yearly. Lengthy discussion on the ALPR cameras and the possibility of putting forth one grant request to include cameras in Alexander Park and updating/replacing the cameras at the Community Center was had. The discussion eroded to C&H whistles, community warning and notification systems, etc, which no resolution was achieved.
- 5.b. MEETING SCHEDULE FOR 2023: A motion to approve the meeting schedule for 2023 was approved by consensus.
6. REPORTS FROM COMMITTEE MEMBERS: Mr. Angell reported that Committee member John Valentini has resigned after many years of service. The Committee will get a plaque for John. Mr. Angell asked if anyone was interested in the vacant position on the Police Liaison Committee, with no response. The open position will be posted.
